18 July, 1944.

1. Lt Col ROBERT G. WILLIAMS, O-437623, is relieved and assigned with the 367th Bomb Sq (H), 306th Bomb Gp (H), and is transferred to Hq, 306th Bomb Gp (H), and will assume the duties of Operations Officer thereof, effective this date.

2. Major CHARLES E. FLYNNAGAN, O-438020, is relieved and assigned with the 369th Bomb Sq (H), 306th Bomb Gp (H), and is transferred to the 367th Bomb Sq (H), 306th Bomb Gp (H), and will assume command thereof, effective this date, vice Lt Col ROBERT G. WILLIAMS, O-437623, relieved.

3. Capt BILLY W. CASSEIDY, O-678162, is relieved and assigned with Hq, 306th Bomb Gp (H), and is transferred to the 369th Bomb Sq (H), 306th Bomb Gp (H), effective this date.

Payable to O only. Reimbursement for EI not to exceed \$2.00 per day is authorized if Government quarters or billets are not available, and an allowance of \$2.00 per day is authorized if Government messing facilities are not available, while traveling and while at TD Station."

6. So much of par 3, SO 178, this Hq, as, dd 4 July, 1944, pertaining to TD of O and EI, as reads: "C-140", is amended to read: "C-140".
